# **KEIM Algicid-Plus**



# **1. Product description**

Ready-to-use, aqueous special cleaning agent with microbiocidal action for remediation and cleaning of outdoor and indoor surfaces suffering from algal and fungal growth. KEIM Algicid-Plus also has a preventive action against new growth.

# 2. Field of application

KEIM Algicid-Plus can be used to treat building materials, in particular natural stone surfaces sensitive to chemicals, affected by algal, fungal and lichen growth.

# **3. Product properties**

Contains no reactive chlorine.

# 4. Application instructions

#### **Initial preparation**

Thoroughly remove any mould growth from indoor surfaces by wet brushing or scraping.

On outdoor surfaces, algae, fungi and lichens are removed by water jetting, ensuring that applicable regulations are observed. If technically feasible, hot water pressure cleaning is recommended.

#### Application

Once the surfaces prepared as above have dried, they should be uniformly soaked with undiluted KEIM Algicid-Plus by brush or flooding (do not spray!).

A single treatment is generally sufficient. Subsequent washing down is not necessary. Once the product has been allowed to act for at least 24 hours, KEIM coating systems can be applied onto the cleaned surface. After indoor application, adequate ventilation must be provided for at least 24 hours.

#### Note

Outdoor application: If a water-repellent KEIM coating system is not applied, a water-repellent final treatment, e.g. using KEIM Lotexan or Lotexan-N, should be applied in order to ensure lasting effectiveness of the remediation.

#### Consumption

On a smooth substrate, approx. 0.25 l/m<sup>2</sup>. Consumption values depend on the nature of the substrate and should be determined on trial areas.

#### Cleaning of tools

Clean with water immediately after use.

In the case of indoor application, adequate ventilation must be provided for at least 24 hours. First aid: In case of inhalation, provide fresh air. Wash wetted skin with soap and water.
